

How to register for an FxChoice Trading Account

1. Account Registration

For start you need to enter your email address and click Next to proceed with registration.



After entering your email, you will be directed to the registration page. Here you'll need to enter your personal details and specify what **account type** you wish to open, specify your **currency** and **leverage**.

Should you experience any difficulty uploading your documents, simply email them to us at backoffice@myfxchoice.com and we'll take care of the rest.

How do I verify my user profile?

We require verification of your identity and address. These requirements can be met by uploading documents listed below to your profile.

To verify your identity, we need to see a clear **colour copy** of the **front and back** of your government-issued photo ID. This could either be done by scanning the document or by taking a high-resolution digital photograph.

The proof of identity document must show your full name, your photo, document number, date of birth, and your complete home address as registered in your FX Choice user profile. All four corners of both the front and back must be visible, and the document must be current and valid.

Acceptable documents:

- Driver license (front and back)
- Passport (including the page showing your signature)
- ID card
- Permanent resident or alien registration card

When sending in your government issued identification document, please ensure it meets the following criteria:

- Use *.jpg, *.jpeg, *.gif, or *.pdf
- Ensure that **all four edges** are clearly visible
- Address on document **MUST** match address on your FX Choice user profile
- **Must submit in COLOR**
- Must be Valid ID (Do not send in expired ID cards)
- Document must be high quality; make sure it is readable
- Include an image of both the front and back of your ID card or Driver's License
